

Promotion Addendum – 2026 RFC Grand Opening

This Addendum (“Promotion Addendum”) to the Master Official Rules – Global Federal Credit Union Promotions, Sweepstakes, and Giveaways (“Master Official Rules”) describes certain rules specific to the **2026 RFC Grand Opening Giveaway** Promotion and incorporates the Master Official Rules by reference. **THIS ADDENDUM DOES NOT CONTAIN ALL OF THE RULES APPLICABLE TO THIS PROMOTION. TO REVIEW ALL APPLICABLE RULES, READ THIS ADDENDUM TOGETHER WITH THE MASTER OFFICIAL RULES.** If there is a conflict between the Master Official Rules and the rules described in this Promotion Addendum, this Promotion Addendum shall control. Capitalized terms not defined herein shall have the meaning attributed to them in the Master Official Rules.

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

Eligibility. The Promotion is open to who visits Global Federal Credit Union’s (Global) Renton Financial Center Branch and enters to win on the Global giveaway landing page which they can access via QR code at the booth, and who otherwise meets the eligibility requirements outlined in the Master Official Rules. They must also be able to attend the Seattle Mariners Home Game on August 7, 2026. The promotion also is open to those who use the alternate method of entry.

Officers, directors, and employees of the MLB Entities and their subsidiaries, affiliates, and advertising and promotional agencies, and the immediate families and individuals living in the same households of such officers, directors, and employees, are ineligible to participate in the Promotion. Immediate family means spouse and parents, children and siblings, and their spouses. “MLB Entities” means the Baseball Club of Seattle, LLLP (the “Club”), the Office of the Commissioner of Baseball (“BOC”), its Bureaus, Committees, Subcommittees and Councils, MLB Advanced Media, L.P. (“MLB”), Major League Baseball Properties, Inc., The MLB Network, LLC, the Major League Baseball Clubs (“Clubs”), each of their parent, subsidiary, affiliated, and related entities, any entity which, now or in the future, controls, is controlled by, or is under common control with the Clubs or the BOC, and the owners, general and limited partners, shareholders, directors, officers, employees, and agents of the foregoing entities. █

Promotional Period. **2026 RFC Grand Opening Giveaway** Promotion runs from 9:00 AM Pacific time July 16, 2026 – 8:00 PM Pacific time July 16, 2026 (“Promotional Period”).

To Enter. Eligible Participants are entered when they complete the entry form that can be found at https://www.globalcu.org/events/renton-financial-center-grand-re-opening/?utm_source=QR&utm_medium=event&utm_campaign=RFCgrandopening with first and last name, phone number and email. All information submitted online by entrants is subject to, and will be treated in a manner consistent with Global FCU’s Privacy Policy (https://www.globalcu.org/about/privacy/online_privacy_notice/). Entrants must fully complete and submit all non-optional data requested on the entry form to be eligible. Incomplete and/or inaccurate entries are void. Only one (1) entry per person will be accepted.

Alternate Method of Entry. In place of the entry method described above, send an email with subject line: **2026 RFC Grand Opening Giveaway** to RFC@globalcu.org with name, address, email and phone number. Emails must be received in the designated inbox a by July 16, 2026 by 8:00 PM Pacific time. Only one (1) entry per person will be accepted.

Selection of Winner. On July 17, 2026, Global FCU will conduct a random drawing from among all eligible entries received during the Promotional Period (subject to verification of eligibility and compliance with this Addendum and the Master Official Rules).

Odds: Estimated odds of winning are dependent upon the number of Eligible Entries received during the Promotional Period.

One (1) Prize Will Be Awarded: One (1) Selected Eligible Participant will receive **Two (2) tickets for winner and one (1) guest to the Seattle Mariners game currently scheduled to take place on August 7, 2026 at 7:10 pm.** Approximate retail value (ARV) \$170.00.

Use of any Major League Baseball game/event/exhibition ticket is subject to the standard terms, conditions, and health and safety policies applicable to the ticket; see mariners.com/ticketback for details. Seat locations at the game/event/exhibition and, unless otherwise stated in the prize description, exact game/event/exhibition date shall be determined in the sole discretion of Sponsor. The Winner's guest(s) must be of legal age of majority in his/her(their) jurisdiction(s) of residence unless accompanied by a parent or legal guardian. Major League Baseball game/event/exhibition dates and times are determined in the sole discretion of the BOC and/or the applicable Club and may be subject to change. The terms and conditions of the tickets awarded as part of the prize will govern in the event a legal game/event/exhibition, as defined by Major League Baseball, is not played or held due to weather conditions, an act of God, an act of terrorism, civil disturbance, or any other reason. Sponsor and MLB Entities will not be responsible for weather conditions; acts of God; acts of terrorism; civil disturbances; local, state, or federal regulation, order, or policy; work stoppage; epidemic, pandemic, or any other issue concerning public health or safety; or any other event outside of their control that may cause the cancellation or postponement of any Major League Baseball game/event/exhibition. Major League Baseball game/event/exhibition tickets awarded as prizes may not be resold, offered for resale, or used for any commercial or promotional purpose whatsoever. Any such resale or commercial or promotional use may result in disqualification and prize forfeiture, and may invalidate the license granted by the game/event/exhibition ticket.

Notification of Winner. Sponsor will notify the Selected Eligible Participant by email or phone between 9:00 am and 5:00 pm Pacific Standard Time on July 20, 2026. The Selected Entrant must respond to Sponsor's notification message by 5:00 pm Pacific time on the calendar day following the day of Sponsor's notification message to acknowledge receipt or the Selected Eligible Participant will forfeit the opportunity to be verified as a winner and Sponsor will draw an alternate Selected Eligible Participant. Sponsor will arrange for transfer of tickets upon winner's response to notification and completion of documents.

Release and Limitation of Liability: By entering the Promotion, each entrant agrees to waive any and all claims against the MLB Entities for any injury, damage, or loss that may occur, directly or indirectly, in whole or in part, from participation in the Promotion, or receipt or use of any prize (or any portion thereof), or any travel or activity related thereto.
