

Promotion Addendum – Mariners Cash Back Credit Card Sweepstakes (“Promotion”)

This Addendum (“Promotion Addendum”) to the Master Official Rules – Global Federal Credit Union (“Sponsor” or “Global”) (Global) Promotions, Sweepstakes, and Giveaways (“Master Official Rules”) describes certain rules specific to the **Mariners Cash Back Credit Card Sweepstakes** Promotion and incorporates the Master Official Rules by reference. **THIS ADDENDUM DOES NOT CONTAIN ALL OF THE RULES APPLICABLE TO THIS PROMOTION. TO REVIEW ALL APPLICABLE RULES, READ THIS ADDENDUM TOGETHER WITH THE MASTER OFFICIAL RULES.** If there is a conflict between the Master Official Rules and the rules described in this Promotion Addendum, this Promotion Addendum shall control. Capitalized terms not defined herein shall have the meaning attributed to them in the Master Official Rules.

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN

Eligibility. The Promotion is open to legal residents of the United States (excluding New York, Rhode Island and Florida), the District of Columbia, Puerto Rico and Guam, who are 18 years of age or older at the time of entry who are current or new Global Credit Union members, have a Global Credit Union Seattle Mariners Cash Back Credit Card prior to the start of the Promotion or apply and get approved for Global Credit Union Seattle Mariners Cash Back Credit Card during the Promotional period, and who are not in default under any Global products and services, and otherwise qualified to participate (“Eligible Participants”). Global reserves the right to verify the eligibility of winners. The Promotion is subject to all applicable federal, state, and local laws and regulations, and is void where prohibited by law.

Officers, directors, and employees of the MLB Entities and their subsidiaries, affiliates, and advertising and promotional agencies, and the immediate families and individuals living in the same households of such officers, directors, and employees, are ineligible to participate in the Promotion. Immediate family means spouse and parents, children and siblings, and their spouses. “MLB Entities” means the Office of the Commissioner of Baseball (“BOC”), its Bureaus, Committees, Subcommittees and Councils, MLB Advanced Media, L.P. (“MLB”), Major League Baseball Properties, Inc., The MLB Network, LLC, the Major League Baseball Clubs (“Clubs”), each of their parent, subsidiary, affiliated, and related entities, any entity which, now or in the future, controls, is controlled by, or is under common control with the Clubs or the BOC, and the owners, general and limited partners, shareholders, directors, officers, employees, and agents of the foregoing entities.

For purposes of this Addendum, the MLB Entities will hereafter be considered a Released Party as defined in the Master Official Rules.

Promotional Period. The **Mariners Cash Back Credit Card Sweepstakes** Promotion runs from 12:00 AM AKST May 1, 2026— 11:59 PM AKST January 31, 2027 (“Promotional Period”). The Promotional Period will be divided into nine (9) monthly entry periods (each, an “Entry Period”). Each Entry Period will begin at 12:00 AM AKST on the first day of a month and end at 11:59 PM AKST on the last day of the same month. Non-winning entries to any Entry Period will not roll over and will not be included in subsequent Entry Periods, if any.

To Enter. Participants will earn one (1) entry for each purchase transaction that posts to their Global Credit Union Seattle Mariners Cash Back Credit Card during the Promotional Period. Every purchase made is automatically entered in the giveaway. Upon entry, Eligible Participants

are entered in the Promotion and become “Entrants”. Entrants agree to the Master Official Rules and this Promotion Addendum and accept Global’s decisions regarding the Promotion as final. In the event of a dispute over the identity of an Entrant, the entry will be deemed as entered by the primary cardholder listed on the card account on the date the entry was earned.

Alternate Method of Entry. Entrants may also submit an online entry into the Promotion on Global’s website by providing the required information at the following link during the Promotional Period. <https://www.globalcu.org/landing-page/seattle-mariners-sweepstakes-form/>

Odds: Estimated odds of winning are dependent upon the number of eligible entries. The winner for the applicable monthly prize will be selected each month beginning June 1, 2026. A winner will be selected each month until the Promotion has ended on January 31, 2027.

Selection of Winners. Monthly drawings will take place on/about the first day of the month following the conclusion of each applicable Entry Period (with the first drawing taking place June 1, 2026). Global or it’s representative will conduct a random drawing from among all eligible entries received. The drawing and prizes will be determined by the schedule listed below

Odds: Estimated odds of winning are dependent upon the number of eligible entries received during each applicable Entry Period.

Month 1 (May): There will be (1) one prize of Mariners Suite Night including twenty (20) tickets for winner and nineteen (19) guests and catering for the Seattle Mariners home game currently scheduled to take place on June 30, 2026. **Approximate Retail Value (“ARV”): \$4,410.00**

Month 2 (June): There will be (1) one prize for a Mariners Fan Flyaway Trip (Includes two (2) Alaska Airlines vouchers (\$500 each, \$1,000 total), one (1) hotels.com electronic gift card (valued at \$800), and two (2) game tickets) for winner and one (1) guest for the Seattle Mariners away game currently scheduled to take place on Thursday July 30, 2026. **ARV: \$2,028.00**

Month 3 (July): There will be (1) one prize of ten (10) tickets for winner and nine (9) guests for the Seattle Mariners August 25, 2026 game and the opportunity for winner and guests to participate in the Pregame Tunnel. **ARV: \$1,790.00**

Month 4 (August): There will be (1) one prize of two (2) tickets for winner and one (1) guest for the Seattle Mariners game currently scheduled to take place on Tuesday September 22, 2026, the opportunity for winner and guest to attend Batting Practice Viewing + the opportunity for the winner and guest to take a photo on the field. **ARV: \$2,000**

Month 5 (September): There will be (1) one prize of a Ballpark Tour for winner and one (1) guest and a Seattle Mariners Prize Pack for winner only, containing merchandise determined by Sponsor. **ARV: \$500**

Month 6 (October): There will be (1) one prize of a Seattle Mariners signed jersey determined by Sponsor in its sole discretion. **ARV: \$1,500**

Month 7 (November): There will be (1) one prize of a signed baseball determined by Sponsor in its sole discretion. **ARV: \$1,250**

Month 8 (December): There will be (1) one prize of Mariners Spring Training Trip Flyaway ((Includes two (2) Alaska Airlines vouchers (\$500 each, \$1,000 total), one (1) hotels.com electronic gift card (valued at \$800), and two (2) game tickets). **ARV: \$2,000**

Month 9 (January): There will be (1) one prize of a \$250 T-Mobile™ ballpark gift card to the Mariners Team Store. **ARV: \$250**

Exact nature and duration of any on-field experience shall be determined in the sole discretion of Sponsor and the Seattle Mariners and is subject to availability. Actual values of autographed items are subject to market fluctuations. No certificate of authenticity is provided by

Sponsor. Items are not used. Use of any Major League Baseball game/event/exhibition ticket is subject to the standard terms, conditions, and health and safety policies applicable to the ticket; see mariners.com/ticketback for details. Seat locations at the game/event/exhibition and, unless otherwise stated in the applicable prize description, exact game/event/exhibition date shall be determined in the sole discretion of Sponsor. Each winner's guest(s) must be of legal age of majority in their jurisdiction(s) of residence unless accompanied by a parent or legal guardian. Major League Baseball game/event/exhibition dates and times are determined in the sole discretion of the BOC and/or the applicable Club and may be subject to change. The terms and conditions of the tickets awarded as part of any prize will govern in the event a legal game/event/exhibition, as defined by Major League Baseball, is not played or held due to weather conditions, an act of God, an act of terrorism, civil disturbance, or any other reason. Each winner and his/her guest(s) agree to comply with all applicable ballpark and venue regulations in connection with the prize; see mariners.com/ballpark for details. Sponsor and the MLB Entities reserve the right to remove or to deny entry to any winner and/or their guest(s) who engage in a non-sportsmanlike or disruptive manner or with intent to annoy, abuse, threaten, or harass any other person at the game/event/exhibition. Sponsor and the MLB Entities will not be responsible for weather conditions; acts of God; acts of terrorism; civil disturbances; local, state, or federal regulation, order, or policy; work stoppage; epidemic, pandemic, or any other issue concerning public health or safety; or any other event outside of their control that may cause the cancellation or postponement of any Major League Baseball game/event/exhibition. Major League Baseball game/event/exhibition tickets awarded as prizes may not be resold, offered for resale, or used for any commercial or promotional purpose whatsoever. Any such resale or commercial or promotional use may result in disqualification and prize forfeiture, and may invalidate the license granted by the game/event/exhibition ticket.

Prize Conditions: Prizes are not transferable and cannot be assigned or redeemed for cash. In the case of unavailability of any prize, Global reserves the right to substitute a prize of equal or greater value.

Notification of Winners: All winners are "Selected Entrants" until Global verifies their eligibility and identity. Selected Entrants will be contacted at the telephone number or email address listed on the account or provided via Global's alternate entry landing page and must complete, sign and submit to Sponsor an affidavit of eligibility, liability, and publicity release, within 48 hours of the time of the prize notification. Winners will be responsible for any tax liability associated with claiming any prize. If a Selected Entrant is unwilling or unable to complete and timely submit to Global any required documentation, the selection will be voided and Selected Entrant forfeits any right to a prize. In the event of forfeiture, Global may draw an alternate winner up to one (1) time. Timely completion and submission of the required documentation and acceptance of the prize constitutes permission (except where prohibited by law) to use the winner's name, hometown, and likeness for purposes of advertising, promotion, and publicity in any media without additional compensation.

Release and Limitation of Liability: By entering the Promotion, each entrant agrees to waive any and all claims against the MLB Entities for any injury, damage, or loss that may occur, directly or indirectly, in whole or in part, from participation in the Promotion, or receipt or use of any prize (or any portion thereof), or any travel or activity related thereto.
