

## **Promotion Addendum – Seattle Mariners Fireworks Viewing Giveaway 2026 (“Promotion”)**

This Addendum (“Promotion Addendum”) to the Master Official Rules – Global Federal Credit Union (“Sponsor” or “Global FCU”) Promotions, Sweepstakes, and Giveaways (“Master Official Rules”) describes certain rules specific to the **Seattle Mariners Fireworks Viewing Giveaway 2026** and incorporates the Master Official Rules by reference. **THIS ADDENDUM DOES NOT CONTAIN ALL OF THE RULES APPLICABLE TO THIS PROMOTION. TO REVIEW ALL APPLICABLE RULES, READ THIS ADDENDUM TOGETHER WITH THE MASTER OFFICIAL RULES.** If there is a conflict between the Master Official Rules and the rules described in this Promotion Addendum, this Promotion Addendum shall control. Capitalized terms not defined herein shall have the meaning attributed to them in the Master Official Rules.

**Eligibility.** The Promotion is open to anyone who is a Seattle Mariners cash back credit card holder and receives an enter to win email, which will include a link to an enter to win landing page to submit their entry, and who otherwise meets the eligibility requirements outlined in the Master Official Rules. They must also be able to attend the Seattle Mariners Home Game that corresponds to the entry they are participating in, which include the following games:

- May 29, 2026, currently scheduled to take place at T-Mobile Park on May 29, 2026 at 7:10 pm (PST).
- June 19, 2026, currently scheduled to take place at T-Mobile Park on June 19, 2026 at 7:10 pm (PST).
- July 17, 2026, currently scheduled to take place at T-Mobile Park on July 17, 2026 at 7:10 pm (PST).
- August 21, 2026, currently scheduled to take place at T-Mobile Park on August 21, 2026 at 7:10 pm (PST).
- September 4, 2026, currently scheduled to take place at T-Mobile Park on September 4, 2026 at 7:10 pm (PST).

Officers, directors, and employees of the MLB Entities and their subsidiaries, affiliates, and advertising and promotional agencies, and the immediate families and individuals living in the same households of such officers, directors, and employees, are ineligible to participate in the Promotion. Immediate family means spouse and parents, children and siblings, and their spouses. “MLB Entities” means the Baseball Club of Seattle, LLLP (the “Club”), the Office of the Commissioner of Baseball (“BOC”), its Bureaus, Committees, Subcommittees and Councils, MLB Advanced Media, L.P. (“MLB”), Major League Baseball Properties, Inc., The MLB Network, LLC, the Major League Baseball Clubs (“Clubs”), each of their parent, subsidiary, affiliated, and related entities, any entity which, now or in the future, controls, is controlled by, or is under common control with the Clubs or the BOC, and the owners, general and limited partners, shareholders, directors, officers, employees, and agents of the foregoing entities.

For purposes of this Addendum, the MLB Entities will hereafter be considered a Released Party as defined in the Master Official Rules.

**Promotional Period.** **Seattle Mariners Fireworks Viewing Giveaway 2026** runs from the date of the giveaway email send and will run for forty-eight hours (“Promotional Period”).

**To Enter:** Eligible Participants are entered when they receive the **Seattle Mariners Fireworks Viewing Giveaway 2026** email, click on the enter to win button and fill out the submission form. found online at <https://www.globalcu.org/events/mariner-fireworks/> with first and last name, phone number and email. By successfully transmitting a completed entry form during the Promotional Period as directed, you will be entered in the Promotion. All information submitted online by entrants is subject to and will be

treated in a manner consistent with Global's Privacy Policy ([https://www.globalcu.org/about/privacy/online\\_privacy\\_notice/](https://www.globalcu.org/about/privacy/online_privacy_notice/)). Entrants must fully complete and submit all non-optional data requested on the entry form to be eligible. Incomplete and/or inaccurate entries are void. Only one (1) entry per person will be accepted.

**Alternate Method of Entry.** In place of the entry method described above, send an email with subject line: **Seattle Mariners Fireworks Viewing Giveaway 2026** to [marketing@globalcu.org](mailto:marketing@globalcu.org) with name, address, email and phone number. Emails must be received in the designated inbox up to forty-eight hours from the email send.

**Selection of Winner.** Global FCU will conduct a random drawing from among all eligible entries received during the Promotional Period (subject to verification of eligibility and compliance with this Addendum and the Master Official Rules).

**Odds:** Estimated odds of winning are dependent upon the number of Eligible Entries received during the Promotional Period.

**One (1) Prize Will Be Awarded:** Ten (10) Selected Eligible Participant will receive one (1) game and fireworks viewing ticket for winner and one (1) game and fireworks viewing ticket for a guest to the 2026 Seattle Mariners games that correspond to the entry email they responded to and are listed above. Approximate retail value (ARV) is \$700.00.

Use of any Major League Baseball game/event/exhibition ticket is subject to the standard terms, conditions, and health and safety policies applicable to the ticket; see [mariners.com/ticketback](http://mariners.com/ticketback) for details. Seat locations at the game/event/exhibition and, unless otherwise stated in the prize description, exact game/event/exhibition date shall be determined in the sole discretion of Sponsor. The Winner's guest(s) must be of legal age of majority in his/her(their) jurisdiction(s) of residence unless accompanied by a parent or legal guardian. Major League Baseball game/event/exhibition dates and times are determined in the sole discretion of the BOC and/or the applicable Club and may be subject to change. The terms and conditions of the tickets awarded as part of the prize will govern in the event a legal game/event/exhibition, as defined by Major League Baseball, is not played or held due to weather conditions, an act of God, an act of terrorism, civil disturbance, or any other reason. Sponsor and MLB Entities will not be responsible for weather conditions; acts of God; acts of terrorism; civil disturbances; local, state, or federal regulation, order, or policy; work stoppage; epidemic, pandemic, or any other issue concerning public health or safety; or any other event outside of their control that may cause the cancellation or postponement of any Major League Baseball game/event/exhibition. Major League Baseball game/event/exhibition tickets awarded as prizes may not be resold, offered for resale, or used for any commercial or promotional purpose whatsoever. Any such resale or commercial or promotional use may result in disqualification and prize forfeiture, and may invalidate the license granted by the game/event/exhibition ticket. **Notification of Winner.** Sponsor will notify the Selected Eligible Participant by email or phone between 9:00 am and 5:00 pm Pacific Standard Time. The Selected Entrant must respond to Sponsor's notification message by 5:00 pm Pacific time on the calendar day following the day of Sponsor's notification message to acknowledge receipt or the Selected Eligible Participant will forfeit the opportunity to be verified as a winner and Sponsor will draw an alternate Selected Eligible Participant. Sponsor will arrange for transfer of tickets upon winner's response to notification and completion of documents.

**Release and Limitation of Liability:** By entering the Promotion, each entrant agrees to waive any and all claims against the MLB Entities for any injury, damage, or loss that may occur, directly or indirectly, in

whole or in part, from participation in the Promotion, or receipt or use of any prize (or any portion thereof), or any travel or activity related thereto.
