

## Promotion Addendum – Permanent Fund Dividend (PFD) Sweepstakes

This Addendum (“Promotion Addendum”) to the Master Official Rules – Global Federal Credit Union (Global FCU) Promotions, Sweepstakes, and Giveaways (“Master Official Rules”) describes certain rules specific to the Permanent Fund Dividend Sweepstakes and incorporates the Master Official Rules by reference. **THIS ADDENDUM DOES NOT CONTAIN ALL OF THE RULES APPLICABLE TO THIS PROMOTION. TO REVIEW ALL APPLICABLE RULES, READ THIS ADDENDUM TOGETHER WITH THE MASTER OFFICIAL RULES.** If there is a conflict between the Master Official Rules and the rules described in this Promotion Addendum, this Promotion Addendum shall control. Capitalized terms not defined herein shall have the meaning attributed to them in the Master Official Rules.

**NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**Eligibility.** In addition to the eligibility requirements outlined in the Master Official Rules, Participants must be Alaska residents who qualify for a Permanent Fund Dividend (PFD) and satisfy the requirements to select Global FCU as the financial institution which will receive their PFD direct deposit. Participants who select Global FCU as their choice for direct deposit are automatically entered. The PFD direct deposit must be posted to their account by October 31, 2023. The promotion is also open to those who use the alternate method of entry.

**Promotional Period.** PFD Sweepstakes runs from 9:00 AM Alaska time August 10, 2023 – 12:00 PM Alaska time August 31, 2023 (“Promotional Period”).

**To Enter.** Eligible Participants who have already selected Global FCU as the recipient of their direct deposit will automatically be entered. Eligible Participants can also enter by updating PFD direct deposit instructions to reflect a Global FCU account by the State of Alaska deadline of 8/31/2023. Instructions to make change:

- log into their MyAlaska account via <https://myinfo.pfd.dor.alaska.gov/>,
- Select “Change Payment Method,”
- Select “Direct Deposit,”
- Enter routing and account number of their Global FCU account,
- Select “submit.”

**Alternate Method of Entry.** Eligible Participants who do not update their direct deposit to Global FCU during the Promotional Period may enter by mailing a 3x5 card labeled “Permanent Fund Dividend Sweepstakes,” with entrant’s name, address, email and phone number to Global Federal Credit Union, attn: Marketing 4000 Credit Union Dr. Anchorage, AK 99503. Mailed entries must be postmarked by August 31, 2023.

**Selection of Winners.** The State of Alaska will provide Global FCU a list of all direct deposits that are scheduled to post to member accounts. Global FCU will use this list to create an Excel spreadsheet, add all the entrants that used the alternate method of entry and assign random numbers to each name. Once the entrant’s eligibility is verified, twenty-five (25) random numbers and the entrant’s associated with those numbers on the list will be the selected entrant’s.

**Odds:** Estimated odds of winning are dependent upon the number of Eligible Participants who enter.

**Prize(s):** Selected Entrants will receive the amount of 2023 PFD payment multiplied by two (2), with a maximum value of \$2,700. Prizes may not be substituted. Sponsor will deposit up to \$2,700 in the Global FCU Account of each of the 25 Selected Entrants. If a Selected Entrant is not a member of Global FCU and wishes to redeem the prize, the winner must open a checking account and Global FCU will deposit up to \$2,700 into the account. The membership fee will be waived.

**Example 1:** A Selected Entrant receives their PFD direct deposited into their Global FCU Account in the amount of \$1,200. The prize awarded would be calculated as:  $\$1,200 \times 2 = \$2,400$ .

**Example 2:** A Selected Entrant receives their PFD direct deposited into their Global FCU Account in the amount of \$1,400. The prize awarded would be \$2,700 as this is the maximum limit for the prize.

**Notification of Winners.** Sponsor will notify each selected entrant by email or phone between 9:00 am and 5:00 pm Alaska time on Friday November 3, 2023. The Selected Entrant must respond to Sponsor's notification message by 5:00 pm Alaska time Monday November 6, 2023 to acknowledge receipt and to confirm an email address for receipt of Documentation, or the Selected Entrant will forfeit the opportunity to be verified as a winner. Sponsor will then draw an alternate entrant from the Excel spreadsheet listing entrants. If a Selected Entrant timely responds to Sponsor's notification message, Sponsor will email the Selected Entrant Documentation, which Selected Entrant must complete, sign, and return to Sponsor: 1) by scanning and emailing to Sponsor by 5:00 pm Alaska time on the second calendar day following the date of Sponsor's email, or 2) by U.S. mail, which must be received by Sponsor by 5:00 pm Alaska time on the seventh calendar day following the date of Sponsor's email.
