Promotion Addendum - Million Points Mania 2025

This Addendum ("Promotion Addendum") to the Master Official Rules – Global Federal Credit Union (Global) Promotions, Sweepstakes, and Giveaways ("Master Official Rules") describes certain rules specific to the Million Points Mania 2025 Promotion and incorporates the Master Official Rules by reference. THIS ADDENDUM DOES NOT CONTAIN ALL OF THE RULES APPLICABLE TO THIS PROMOTION. TO REVIEW ALL APPLICABLE RULES, READ THIS ADDENDUM TOGETHER WITH THE MASTER OFFICIAL RULES. If there is a conflict between the Master Official Rules and the rules described in this Promotion Addendum, this Promotion Addendum shall control. Capitalized terms not defined herein shall have the meaning attributed to them in the Master Official Rules.

Eligibility. The Promotion is open to legal residents of the United States (excluding New York, Rhode Island and Florida), the District of Columbia, Puerto Rico and Guam, who are 18 years of age or older at the time of entry who are current or new Global Credit Union members, have an Global Credit Card prior to the start of the Promotion or apply and get approved for Global Credit Card during the Promotional period, and who are not in default under any Global products and services, and otherwise qualified to participate in the Scorecard Rewards Program ("Eligible Participants"). Global reserves the right to verify the eligibility of winners. The Promotion is subject to all applicable federal, state, and local laws and regulations, and is void where prohibited by law.

Promotional Period. The **Million Points Mania 2025** Promotion runs from 12:00 AM AKST November 17, 2025—11:59 PM AKST January 9, 2025 ("Promotional Period").

To Enter. Eligible Participants who remain eligible for the full Promotional Period will automatically receive one (1) entry in the Promotion. Eligible Participants also will earn one (1) additional entry for each purchase transaction that posts to their Global Credit Card with ScoreCard Rewards during the Promotional Period. Every purchase, including cash withdrawals, counts as an entry for the giveaway. Balance transfers do not count towards giveaway entries. Upon receipt of an entry, Eligible Participants are entered in the Promotion and become "Entrants". Entrants agree to the Master Official Rules and this Promotion Addendum, and accept Global's decisions regarding the Promotion as final. In the event of a dispute over the identity of an Entrant, the entry will be deemed as entered by the primary cardholder listed on the card account on the date the entry was earned.

Alternate Method of Entry. Participants will receive one (1) free entry simply for being Global Credit Card cardholders. Entrants without a Global Credit Card may also submit (1) online entry into the Promotion on Global's website by providing the required information at the following link during the Promotional Period. www.globalcu.org/MPMalternateentries

Odds: Estimated odds of winning are dependent upon the number of eligible participants that enter. Winners for the weekly prize will be selected each week beginning November 24, 2025. The grand prize winner will be selected after the Promotion has ended on January 12, 2026. **Weekly runner-up prize winners are still eligible for the grand prize.**

Prize(s): One Grand Prize of 1,000,000 ScoreCard Reward Points and (9) Nine weekly runner-up prizes of 50,000 ScoreCard Reward Points. ScoreCard Rewards points may be used for travel or merchandise, at winner's options, redeemed through ScoreCard Rewards.

- Week 4: There will be (1) one prize of 50,000 ScoreCard Reward points drawn on December 15, 2025.

 Approximate Retail Value (ARV): \$600 but varies depending on items(s) redeemed.
- Week 5: There will be (1) one prize of 50,000 ScoreCard Reward points drawn on December 22, 2025.

 Approximate Retail Value (ARV): \$600 but varies depending on items(s) redeemed.
- Week 6: There will be (2) two prizes of 50,000 ScoreCard Reward points drawn on December 29, 2025.

 Approximate Retail Value (ARV): \$600 but varies depending on items(s) redeemed.
- Week 7: There will be (2) two prizes of 50,000 ScoreCard Reward points drawn on January 5, 2026.

 Approximate Retail Value (ARV): \$600 but varies depending on items(s) redeemed.

Grand Prize Winner. There will be one (1) Grand Prize winner drawn on January 12, 2026. The winner will win: 1,000,000 ScoreCard Rewards points which may be used for travel or merchandise, at winner's option, redeemed through ScoreCard Rewards.

Approximate Retail Value (ARV): \$12,000 but varies depending on items(s) redeemed.

FOR ALL PRIZES: please note the ScoreCard Rewards Points value is approximate and varies slightly, depending upon the value of the good or service for which they are redeemed.

Prize Conditions: Prizes are not transferable and cannot be assigned or redeemed for cash, except at Global's sole discretion. In the case of unavailability of any prize, Global reserves the right to substitute a prize of equal or greater value. Prizes are subject to the terms and conditions relating to points earned in the ScoreCard Rewards Program, which can be found here.

Notification of Winners: All winners are "Selected Entrants" until Global verifies their eligibility and identity. Selected Entrants will be contacted at the telephone number, email address, or SMS text phone number listed on the account or provided via Global's alternate entry landing page and must complete, sign and submit to Sponsor an affidavit of eligibility, liability, and publicity release, within 48 hours of the time of the prize notification. The winning of a prize is a taxable event and Selected Entrants will be required to provide their Social Security number and related information and agree to receive an IRS Form 1099. Winners will be responsible for any tax liability associated with claiming any prize.
